Lotus Eye Hospital And Institute Limited, at their meeting held on 13th February 2023 as a Scrutinizer for the purpose of Scrutinizing the e-voting process on postal ballot in respect of the Resolutions mentioned in the Postal Ballot Notice dated 13th February 2023.

My responsibility as a Scrutinizer is to ensure that the voting process through electronic means in a fair and transparent manner and to furnish a Scrutinizer's Report of the total votes cast in favour or against if any, to the Director Authorised on the resolutions, based on the reports generated from the electronic means provided by Central Depository Services (India) Limited (CDSL).

I submit my report as under: -

- 1. As per the General Circular Nos. 14/2020 dated 8th April 2020, 17/2020 dated 13th April 2020, 22/2020 dated 15th June 2020, 33/2020 dated 28th September 2020, 39/2020 dated 31st December 2020, 10/2021 dated 23rd June 2021, 20/2021 dated 08th December 2021, 3/2022 dated 5th May 2022 and 11/2022 dated 28th December 2022 issued by the Ministry of corporate Affairs (MCA Circulars) as amended from time to time and Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulation 2015 (Listing Regulations) and on account of thread posed by COVID-19 pandemic situation, the Company has sent the Postal Ballot Notice dated 13th February 2023 only in electronic form in accordance with the relaxation granted by the Ministry of Corporate Affairs vide Circular dated 31st December 2020, to all the shareholders whose names appear on the Register of Members / list of Beneficial Owners as received from National Securities Depository Limited (NSDL) / Central Depository Services (India) Limited (CSDL) as at the close of business hours on 14th February, 2023 and who have registered their email ID with Company / Depository.
- 2. As per MCA Circulars and on account of the threats posed by the COVID-19 pandemic, physical copies of the Notice, postal ballot forms and pre-paid Business Reply Envelopes were not dispatched to Members for this Postal Ballot. Accordingly, the communication of the assent or dissent of the members had taken place through the remote e-voting system only.
- 3. The Members of the Company holding equity shares, as on the "cut-off date" i.e. Tuesday 14th February 2023 were entitled to vote on the proposed resolutions as set out in the Notice of Postal Ballot dated 14th February 2023, through remote e-voting only.
- 4. The Company has appointed Central Depository Services (India) Limited (CSDL) for facilitating e-voting to enable the Members to cast their votes electronically. The remote e-voting facility was kept open from 9.00 A.M. on Friday, 17th February 2023 and ends at 5.00 P.M. on Saturday, 18th March 2023. The e-Voting facility was blocked forthwith thereafter.
- 5. The details containing, inter-alia, list of equity shareholders, who voted "For" and "Against", were downloaded from the e voting website of Central Depository Services (India) Limited (CDSL) (https://www.evotingindia.com).
