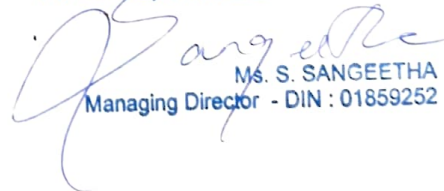

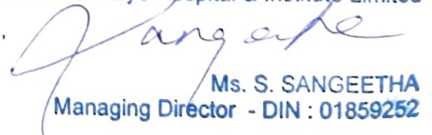

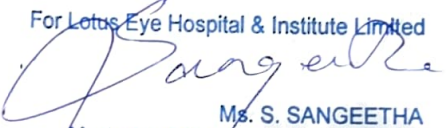

Limited review report for the Quarter/Half year ended September 30, 2024

1.
